Before me this date personally appeared NELSON, DAIMEON (14469) who being first duly sworn deposes and says that on 30 day of January, (year) 2025 at 5723 WHITE HICKORY CIR, TAMARAC, FL 33319 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows:

On February 23, 2025, I Deputy D. Nelson met with the complainant/victim, identified as [REDACTED] who reported ongoing threats made against him by the defendant, Giuliano Puzo DOB 3/3/88). Upon further review of the transcripts the defendant also violated F.S.S. 836.10 Written Threats to Kill through him on a recorded podcast. The suspect also stated Giuliano Puzo (aka DJ K9), had sent him multiple text messages containing direct threats to kill him. Text messages, podcast audio and

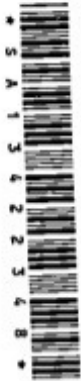

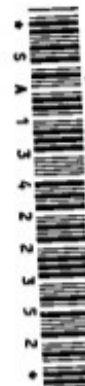
